- Booth fees are \$25 per vendor and are waived for non-profit organizations.
- Check-in/Setup begins at 3:00pm. All booths must be set up and all vehicles removed from the square no later than 4:45pm (unless you are a food truck)
- Vendor areas are split into 4 locations around the square: (1) Food, (2) Arts & Crafts, (3) Children's Play Area, (4) Non-profit / Informational organizations. Booth space is FIRST COME, FIRST SERVE in your designated location.
- Vendors are responsible for tables, chairs, electrical cords, or any amenities you will need during the event. We request ALL vendors to stay open until 9:00pm. No vehicles will be allowed on the square till after 9:00pm. Food vendors are responsible for checking with the Talladega Health Department for inspections and forms.
- The April on the Square committee reserves the right to reject any material it deems unsuitable. Vendors are responsible to comply with the State of Alabama tax regulations.
